

## **PRIVACY POLICY**

This privacy policy applies to bristleconelending.com and all subdomains of bristleconelending.com (the "Website"), owned and operated by Bristlecone, Inc ("Bristlecone", "we" or "us"). Yourprivacy and the protection of your personal information are important to us. Because we collect and/store certain types of information from you and about you, it is necessary to explain our policy, including the terms and conditions surrounding the collection and use of that information.

Personal information means any information about you, identifies you, and that you or a third party provides to us in connection with the closed-end consumer lease.

This Privacy Policy discloses what information we collect, how we use that information, as well as the choices you can make about the way your information is collected and used. Please read this Privacy Policy carefully to understand what we do.

| What?        | We collect personal and financial information from you while you use the Website, and most of this collection occurs during the prequalification and application process. Some information is required and some is optional.  The types of personal information we collect and share depend on the product or service you have with us. This information can include: |

contact us through our Website with questions about our company or lending operations. We collect this information for the purpose of responding to such inquiries.

We also collect information about your computer hardware or software. This information may include your IP address, browser type, domain names, access times, and referring website addresses. We (and/or our service providers) use this aggregated information in the administration of our Website to improve its usability and to evaluate the success of certain marketing/advertising campaigns. We (and/or our service providers) use non-identifying and aggregated information to help optimize our Website based on the needs of our users. This information may also be collected by Google Analytics (www.google.com/policies/privacy/partners/).

You authorize your wireless operate to useyour mobile number, name, address, email, network status, customer type, customer role, billing type, mobile device identifiers (IMSI and IMEI) and other subscriber status details, if available, to allow verification of your identity and to compare information you have provided to GIACT with your wireless operator account profile information for the duration of the business relationship with us.

Compliance with State and Federal Laws. We follow state law if state law provides you with additional privacy protections. For instance, if (and while) your billing address is in Vermont, we will treat your account as if you had exercised the opt-out choice described above and you do not need to contact us to opt out. When you register with our Website through the prequalification and application process, you may receive emails or text messages that confirm specific actions you requested in the prequalification, application, and lease processing stages. These are transactional notifications that you cannot opt out of receiving, as they are in place to protect the security of your account and your personal information. We may also send you responses to emails you send us, if appropriate or applicable. From time to time, we will also send user surveys, requests for user feedback regarding user experience and site operations or marketing offers from us or from us on behalf of our marketing partners. If you do not wish to receive these offers, surveys or user feedback emails, please opt out in any offer email you receive from us.
